

Joint Use Agreement Review
Communiqué #4
February 2005

The Joint Use Agreement (JUA) partners (City of Edmonton, Edmonton Catholic School Board and Edmonton Public School Board) review team held its fourth meeting February 17, 2005 to continue discussions and designing of the new JUA agreement.

At the previous meeting in January 2005, the JUA Review Team reviewed the Joint Use Agreement Document clause by clause to identify areas of the JUA that needed clarification, revision to address current demands, understanding, re-wording, or discussed to create something new; this information will be utilized in the future meetings as the various areas of the JUA are reviewed in detail, and as the JUA Review Team moves forward on any amendments or enhancements to the current agreement.

The JUA partners completed informal "presentations" of their respective organization's focussing on their values, strategic directions, business plans and information that will be helpful for their partners to know as it relates to the JUA. The JUA Review Team also explored some fundamental aspects of the JUA, the definitions and meanings on a broad level, with a focus on the issues and elements related to Reciprocal Use.

The JUA Review Team continues to identify issues and opportunities as they relate to the JUA, and these shall continued to be explored in greater detail through the upcoming regular JUA Review Team meetings. The Review Team will continued to determine the type of information that will be needed for working through the issues, the most appropriate methods in which to solicit public input, involve stakeholders, identify the type of information needed, and the most appropriate mechanism to obtain the information, issue by issue.

Collectively the Review Team will provide regular updates on progress as the Partnering Organizations work through the review process to create a new JUA that is reflective of current needs for all partnering organizations.
