The Province has indicated that new economic realities will likely affect funding to provincially supported entities. We understand the challenges affecting the Province. Our commitment and focus will continue to be on our students in the classroom as we embrace the ministerial order that mandates us to provide educational programs that supports our students in becoming ethical citizens, engaged learners with an entrepreneurial in spirit.



OUR CHALLENGES

The Province is experiencing significant revenue shortfalls. It is predicted that this shortfall will continue for some time. The previous government had instituted a series of funding changes to education that would have significantly reduced the amount of money available to the District. This funding shortfall would be in the range of \$18 million. The newly elected government has promised that funding will be restored and in particular funding for new student enrollment. This budget had been prepared based on our belief that funding will be restored using previous funding policies. Even with the restored funding the District is facing a number of challenges:

 With funding levels restored the District can now assess prudent courses of action and will work with our stakeholders and Alberta Education to ensure our students' success continues to be the focus of our actions.

 Enrollment continues to increase and a large portion of these students are immigrants and refugees who require support in learning the English language.

 Our Inclusive Education model supporting students in the classroom requires increasing support.

 The Province as well as the District has set a goal to ensure our First Nations, Métis and Inuit students have adequate support and we continue to provide support for these students.

 We recognize the potential for future funding reductions and as a result we have initiated a plan to identify and reduce operational expenses. Our considerations include:

» Reducing and/or eliminating district support for some educational priorities

» Finding operational savings in schools and departments

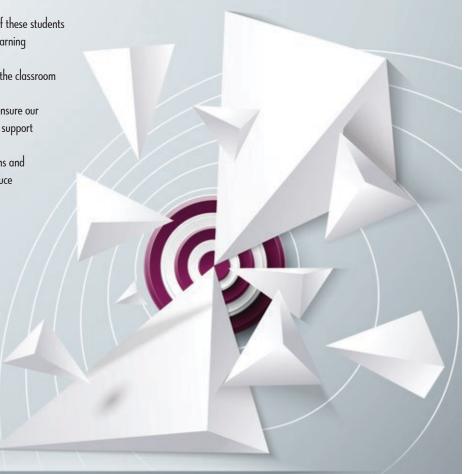
» Assessing consolidation of administrative offices

» Eliminating leases where costs out weigh benefits

» Reviewing our Alternative Education programs to ensure efficiency and effectiveness

» Improving instructional productivity through calendar planning

» Considering consolidation of schools



OUR BUDGET PROCESS

Our budget process is centred by our Core Budget Committee composed of five members of the District's senior administration team, three school principals and two Financial Services managers. This committee was charged with overseeing the development of the budget to ensure consideration is given to all the important components that are foundational in ensuring our students have a quality education in a faith filled environment. Our budget process included researching and assessing factors in our internal and external environment that have an impact on our budget.

We reviewed all of our foundational documents with special attention on our Guiding Principles. We solicited stakeholder input through the use of surveys and discussion groups. Parents, students and employee groups were asked a series of questions relating to their views on relevant issues. Our budget incorporates these views while balancing student needs with the resources available to us. Of high priority were the issues of class size, faith formation, support for special needs, and the need for prudent fiscal management.

OUR DISTRICT GUIDING PRINCIPLES

Our guiding principles are the foundational piece in the development of our budget

- Budgetary resources are allocated such that the District can effectively celebrate and promote Catholic education and therefore, to help ensure that the mission of the District will be actualized
- The budget will be balanced; today's dollars for today's students
- Every student has a full range of learning opportunities that meet their needs to complete the mandated Program of Studies, with appropriate supports and resources
- · Funding allocations support the District Plan for Continuous Growth
- Funding supports the Statement of 21st Century Learning in Edmonton Catholic Schools
- · Student success is the direct or indirect focus of all budgetary allocations
- Every student has access to an equitable share of budget resources

OUR GOALS

We incorporate our District goals into our District Plan for Continuous Growth and align them with Alberta Educations goals. The Province has four goals while we have five with our first goal being of paramount importance and central to our mission. These are our goals:

OUR BUDGET ASSUMPTIONS

Budget 2015-16 is prepared based on the information available at the time of preparation. We have relied primarily on the Alberta Education Funding Manual along with policy statements made by the Ministry. The key budget assumptions used for our Budget 2015-16 are as follows:

- New student enrollment will be funded at the Alberta Education revised funding manual rates
- Some other funding envelopes will also be funded at higher rates
- Inflationary cost pressure will be minimal
- Teacher salary costs are funded appropriately through the basic grant rate
- Teacher salary lump sum payment of 1% due in November 2015 is fully funded
- The new Education Act will not result in additional costs to the District
- The District will continue with its site based model using our existing allocation methodology

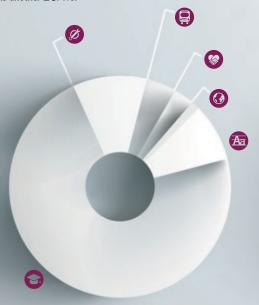

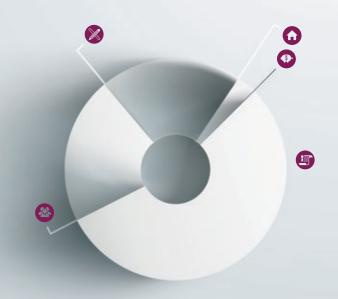

OUR BUDGET AND FINANCIAL SCHEDULES FOR 2015-16

Our Budget for 2015-16 is a balanced budget with revenues of \$459 million and expenses of \$459 million. In Budget 2015-16 80.3% is spent on instructional expenses demonstrating our District's commitment to front line student support. Our Plant Operations & Maintenance Budget is 10.9% and External Services 1.2%. Expenditures on Administration is 3.1% well below the Provincial guidelines of between 3.5% to 4.0%. Our expenses by Account show that 76.5% is related to salaries and benefits while Services, Contracts and Supplies is another 20.4%.

Alberta Education funding of \$423 million accounts for over 92% of the District's revenue highlighting the dependence of the District on the Province. The federal government provides about \$5 million in funding with the balance of our funding largely being generated by the schools and District activities. Funds raised in the schools are cost based and are usually expensed in the same year for the purposes for which they are raised.

ACCUMULATED SURPLUS FROM OPERATIONS

The District's accumulated surplus from operations is the result of savings that are carried over from a year-end to be spend on projects in the coming year. As well, often grants and other revenues arrive late in the school year and do not allow enough lead time to be spent in the current year. It is important to understand the nature of operating expenses and to ensure school budgets are sustainable. To this end surpluses provide a cushion to alleviate short term revenue issues or to accommodate critical planned or unplanned expenses.

For instance a computer lab can cost up to \$60,000 so it is incumbent on a school to be prudent with their spending so funds can be accumulated to make this purchase in a subsequent year. I-Pads, science labs, electrical equipment and sports uniforms are other examples of one time purchases coming out of operating surpluses. There are many more examples of school and district needs which are accommodated in subsequent years from accumulated surpluses.
