PARENT AND STUDENT CONSENT FORM

Both the parent and student must read and agree with the following expectations and rules for participating in the International Student Program. A printed, signed copy needs to be emailed to complete the application.

1. Students are expected to observe and abide by all Edmonton Catholic School Division (ECSD) policies, school rules, regulations, and expectations. Students who fail to comply may be withdrawn from the program and may be required to return home.
2. ECSD is not liable for losses/expenses incurred as a result of being unable to provide education due to labour disputes, inclement weather or other causes beyond its control.
3. I hereby waive, release, absolve and agree to indemnify and save ECSD, all school and board officials, employees, agents, volunteers, and representatives or any of them from all liability arising from the student applicant in the educational program except such as results solely from its or their willful neglect or willful default.
4. I understand that the information shared in the application form, together with information and materials of any kind received from any source, becomes the property of ECSD, and will not be returned. The information collected may also be shared with Division agents and third parties external to ECSD as required to assist with student programming, housing, relocation, or immigration status.
5. I understand that the International Student Program is intended for international students who wish to attend a 'regular' academic program and are achieving at grade level and are developmentally appropriate for their years and associated grade levels.
6. I confirm that the student applicant does not require additional or specialized learning supports. I understand that ECSD may not be able to provide the supports and that all extra costs incurred will be at the expense of the student's family.
7. I declare that the student applicant has no history of criminal behavior, sexual impropriety, or mental health issues.
8. I understand and agree that the applicant student may not live alone during the program while under the age of 18.

9. I understand and agree that the applicant student is not allowed to drive motor vehicles nor work for the duration of the program.
10. I agree to provide sufficient funding for the applicant student's personal spending, living and travel expenses for the duration of the program.
11. I am aware that as part of the school curriculum, the student applicant may participate in field trips outside of the school and I authorize the custodian to provide the necessary permissions.
12. I understand that an online PowerSchool account will be assigned, and password given to access information about the applicant student's attendance, behaviour and marks, and that these credentials may be shared with natural parents, custodian and/or homestay parents.
13. I understand that information about the student applicant's attendance, behaviour and marks may be shared with natural parents, agents retained by parents, custodian and/or homestay parents during the duration of the program.
14. I certify that all the information provided within the application is complete, factually accurate and honest.
