

# BYLAW #2020-01 ESTABLISHMENT OF WARDS

WHEREAS pursuant to the provisions of the *Education Act,* R.S.A. 2012, c.E-0.3, s. 76(1)(a), the Board of the Trustees of Edmonton Catholic Separate School Division may provide for the nomination and election of wards and determine the boundaries of the wards;

**AND WHEREAS** pursuant to Ministerial Order #006/2020, lands described within the order were added to the boundaries of Edmonton Catholic Separate School Division;

**NOW THEREFORE** it is hereby resolved and engaged as a bylaw that:

- 1. The number of wards shall be seven (7);
- The seven (7) wards for the election of trustees representing the Edmonton Catholic Separate School Division are located fully within and extend to the municipal boundaries of the City of Edmonton;
- 3. The seven (7) wards for election of trustees representing the Edmonton Catholic Separate School Division shall be as depicted on Schedule A to this bylaw and as described on Schedule B to this bylaw; and,
- 4. The candidate receiving the greatest number of votes in each ward shall be elected as trustee for that ward:
- 5. Bylaw #2016-01 is hereby repealed.



#### Ward 71

Commencing at the intersection of the City of Edmonton boundary and Stony Plain Road NW. Using the centre line of the road rights of way proceed easterly along Stony Plain Road NW to the intersection with 170 Street NW. Proceed southerly along 170 Street NW to the intersection with 95 Avenue NW. Easterly along 95 Avenue NW to the intersection with 149 Street NW, north along 149 Street NW to the intersection with Stony Plain Road NW. Easterly following Stony Plain Road NW to the northeast corner of the boundary of Plan 9723890 Block 7 Lot 9, proceed south, west along the boundaries of Plan 9723890 Block 7 Lots 9,2-7 to the intersection of 101 Avenue NW and Ravine Drive NW. Proceed southeasterly along Ravine Drive NW to the intersection with 142 Street NW. North on 142 Street NW to intersection of 111 Avenue NW. Easterly along 111 Avenue NW to the intersection of 97 Street NW. North along 97 Street to intersection with 127 Avenue NW. West along 127 Street NW to intersection of 113A Street NW. North following 113A Street NW to intersection with Castledowns Road NW. North following Castledowns Road NW to intersection with 112 Street NW. Northwesterly and north following 112 Street NW to projection of south boundary of Plan 8821652 portion of NE 6-54-24-4. Westerly, northerly and southwesterly following the southerly boundary of Plan 8821652 through NW 6-54-24-4, SE 7-54-24-4, NW 6-54-24-4 and Plan 7720643 Lot A to south

boundary of Plan 7720643 Lot A. West along south boundary of Plan 7720643 to centreline of road rights of way for 127 Street NW. North along 127 Street NW to projection of south boundary of Plan 4564NY Lot A. West along south boundary of Plan 4564NY Lot A to southwest corner, north along west boundary to intersection with Plan 1620162. West, North, Southwesterly along northerly and westerly boundary of Plan 1620162 to intersection with South boundary of Plan 1620752 to intersection with Goodridge Boulevard. West along south boundary of Plan 5780NY to north east corner of Plan 0221071. Southwesterly along the easterly boundary of Plan 0221071 to the intersection with Anthony Henday Drive. Southwesterly along Anthony Henday Drive to the intersection with the City of Edmonton boundary. Proceed southwesterly and southerly following the City boundary to point of commencement.

#### Ward 72

Commencing at the intersection of the City of Edmonton boundary and 34 Street NW. Using the centreline of the road rights of way proceed south along 34 Street NW to the intersection with Manning Drive NW. Proceed southwesterly along Manning Drive NW to the intersection with 153 Avenue NW. Westerly following 153 Avenue NW to intersection with 82 Street NW. South along 82 Street NW to intersection with 127 Avenue NW. West along 127 Avenue NW to intersection with 113A Street NW. North following 113A Street NW to intersection with Castledowns Road NW. North following Castledowns Road NW to intersection with 112 Street NW. Northwesterly and north following 112 Street NW to projection of south boundary of Plan 8821652 portion of NE 6-54-24-4. Westerly, northerly and southwesterly following the southerly boundary of Plan 8821652 through NW 6-54-24-4, SE 7-54-24-4, NW 6-54-24-4 and Plan 7720643 Lot A to south boundary of Plan 7720643 Lot A. West along south boundary of Plan 7720643 to centreline of road rights of way for

127 Street NW. North along 127 Street NW To projection of south boundary of Plan 4564NY Lot A. West along south boundary of Plan 4564NY Lot A to southwest corner, north along west boundary to intersection with Plan 1620162. West, North, Southwesterly along northerly and westerly boundary of Plan 1620162 to intersection with South boundary of Plan 1620752 to intersection with Goodridge Boulevard. West along south boundary of Plan 5780NY to north east corner of Plan 0221071. Southwesterly along the easterly boundary of Plan 0221071 to the intersection with Anthony Henday Drive. Southwesterly along Anthony Henday Drive to the intersection with the City of Edmonton boundary. Proceed north, east, north and east following the City boundary to point of commencement.

### Ward 73

Commencing at the intersection of the City of Edmonton boundary and 34 Street NW. Using the centreline of the road rights of way proceed south along 34 Street NW to the intersection with Manning Drive NW. Proceed southwesterly along Manning Drive NW to the intersection with 153 Avenue NW. Westerly following 153 Avenue NW to intersection with 82 Street NW. South along 82 Street NW to intersection with 127 Avenue NW. West along 127 Avenue NW to intersection with 97 Street NW. South along 97 Street NW to intersection with 111 Avenue NW. East on 111 Avenue NW to 90 Street NW, continue east along 112 Avenue NW to intersection with east boundary of CNR rights of way from the Edmonton Settlement Plan 19, southwesterly along the east boundary of rail rights of way to intersection with 84 Street NW, south along 84 Street NW to Jasper Avenue NW, southwesterly along Jasper Avenue NW to intersection with 92 Street NW, south along 92 Street NW to laneway north of 102A Avenue NW, east along laneway to intersection with boundary of Edmonton Settlement Plan River Lot 20, southeasterly along the southwest boundary to intersection with 103A Avenue NW, easterly along 103A Avenue NW to northwest corner of Plan 0120776 Block 3 Lot 1, easterly along north boundary of Plan 0120776 Block 3 Lot 1 to North Saskatchewan River. Continue northeasterly along the North Saskatchewan River to the intersection with the City boundary. Proceed Easterly, northerly and westerly along City boundary to point of commencement.

## Ward 74

Commencing at the intersection of the City of Edmonton boundary and Stony Plain Road NW. Using the centre line of the road rights of way proceed easterly along Stony Plain Road NW to the intersection with 170 Street NW. Proceed southerly along 170 Street NW to the intersection with 95 Avenue NW. Easterly along 95 Avenue NW to the intersection with 149 Street NW. South along 149 Street NW to intersection with Whitemud Drive NW. Southeasterly along Whitemud Drive NW to the North Saskatchewan River. Proceed southwest along the North Saskatchewan River to the extension east of the south west City of Edmonton boundary. Follow the City boundary west, north, west and north to the point of commencement.

#### Ward 75

Commencing at the intersection of the City of Edmonton boundary and Whitemud Drive NW. Using the centreline of the road rights of way proceed west following Whitemud Drive NW to the intersection with the extension southerly of the east boundary of the closed portion of 45th Avenue NW as shown on Plan 8822507. North along east boundary of Plan 8822507 to intersection with south boundary of Plan 4002MC Block R. Following the boundary of Plan 4002MC Block R proceed westerly and northerly to intersection with the southeast corner of Plan 996TR Lot 25B. Proceed west, northwest and northeast to the northeast corner of Plan 996TR Lot 25B. Continue following the west boundary of Plan 4002MC Block R to the intersection with the southeast corner of Plan 2782NY Lot R. Follow the south boundary of Plan 2782NY Lot R to the intersection with 142 Street NW. North along 142 Street NW to intersection with 51 Avenue NW, east along 51 Avenue NW centreline to projection of northeast boundary of Plan 2782NY Lot B. Proceed southwest, northeast along north boundary of Lot B to intersection with west boundary of Plan 4002MC Block R continue to northwest corner of Block

R. Continue west along the centreline of 53 Avenue NW to the intersection with 141 Street NW, north along 141 Street NW to south boundary of Plan 8922334, follow boundary of Plan 8922334, east, north, west south to intersect with 60 Avenue NW. Continue west along 60 Avenue NW rights of way to lane east of 143 Street NW, north along lane rights of way centreline to southwest boundary of Plan 689RS Block 11 Lot 7. North along the northeastern boundary of block 11 to the intersection with Whitemud Drive NW. Follow northerly along Whitemud Drive NW to the intersection with 149 Street NW. North along 149 Street NW to intersection with Stony Plain Road NW. Easterly following Stony Plain Road NW to projection of the west boundary of Plan 9723890 Block 7 Lot 1, proceed southerly and southeasterly along the south boundaries of Plan 9723890 Block 7 Lots 1-7 to the intersection of 101 Avenue NW and Ravine Drive NW. Proceed southwesterly along Ravine Drive NW to the intersection with 142 Street NW. North on 142 Street NW to intersection with 111 Avenue NW. Easterly along 111 Avenue NW to intersection with 90 Street NW, continue east along 112 Avenue NW to intersection with east boundary of CNR rights of way from the Edmonton Settlement Plan 19, southwesterly along the east boundary of rail rights of way to intersection with 84 Street NW, south along 84 Street NW to intersection with Jasper Avenue NW, southwesterly along Jasper Avenue NW to intersection with 92 Street NW, south along 92 Street NW to laneway north of 102A Avenue NW, east along laneway to intersection with boundary of Edmonton Settlement Plan River Lot 20, southeasterly along the southwest boundary to intersection with 103A Avenue NW, northeasterly along 103A Avenue NW to northwest corner of Plan 0120776 Block 3 Lot 1, easterly along north boundary of Plan 0120776 Block 3 Lot 1 to North Saskatchewan River. Proceed northeasterly following the North Saskatchewan River to the projection northerly of the east boundary of the City of Edmonton. Follow the City boundary south, east and south to the point of commencement.

### Ward 76

Commencing at the intersection of the City of Edmonton boundary and Gateway Boulevard SW. Using the center of the road rights of way proceed northerly along Gateway Boulevard NW to the intersection with Whitemud Drive NW. Proceed west following Whitemud Drive NW to the intersection

with the extension southerly of the east boundary of the closed portion of 45th Avenue NW as shown on Plan 8822507. North along east boundary of Plan 8822507 to intersection with south boundary of Plan 4002MC Block R. Following the boundary of Plan 4002MC Block R proceed westerly and northerly to the intersection with the southeast corner of Plan 996TR Lot 25B. Proceed west. northwest and northeast to the northeast corner of Plan 996TR Lot 25B. Continue following the west boundary of Plan 4002MC Block R to the intersection with the southeast corner of Plan 2782NY Lot R. Follow the south boundary of Plan 2782NY Lot R to the intersection with 142 Street NW. North along 142 Street NW to intersection with 51 Avenue NW, east along 51 Avenue NW centreline to projection of northeast boundary of Plan 2782NY Lot B. Proceed southwest, northeast along north boundary of Lot B to intersection with west boundary of Plan 4002MC Block R continue to northwest corner of Block R. Continue west along the centreline of 53 Avenue NW to intersection with 141 Street NW, north along 141 Street NW to south boundary of Plan 8922334, follow the boundary of plan, east, north, west south to intersect with 60 Avenue NW. Continue west along 60 Avenue NW rights of way to lane east of 143 Street NW, north along lane rights of way centreline to southwest boundary of Plan 689RS Block 11 Lot 7. North along the northeastern boundary of block 11 to the intersection with Whitemud Drive NW. Follow northerly along Whitemud Drive NW to the North Saskatchewan River. Proceed southwest along the North Saskatchewan River to the extension east of the south west City of Edmonton boundary. Follow the City boundary southwesterly, southeasterly, south to intersect with Highway 19. Follow the City boundary east along Highway 19 to the intersection with the south boundary of Plan 8821332. Continue along

City boundary east, northeast to intersect with 41 Avenue SW. East along 41 Avenue SW to point of commencement.

### Ward 77

Commencing at the intersection of the City of Edmonton boundary and Gateway Boulevard SW. Using the center of the road rights of way proceed northerly along Gateway Boulevard NW to the intersection with Whitemud Drive NW. Easterly following Whitemud Drive NW to intersection with City of Edmonton Boundary. Proceed east, south following the City of Edmonton boundary to intersect with 73 Avenue SW. Follow City boundary west along 73 Avenue SW to intersect with 34 Street SW. Follow City boundary north along 34 Street SW. Continue along City boundary west, south, west, south to intersect with 73 Avenue SW. Follow City boundary west along 73 Avenue SW to intersect with 91 Street SW. Continue along City boundary north to intersect with 41 Avenue SW. Follow 41 Avenue SW west along the City boundary to the point of commencement.
